Polychlorinated Naphthalenes

Although the industrial production of polychlorinated naphthalenes (PCNs) ceased in the 1970s/1980s, their persistance in the environment as well as their formation during incineration processes has resulted in an ongoing demand for certified reference standards for this group of compounds. In response to customer requests, Wellington has expanded our line of native PCNs and prepared mixtures that we hope will aid laboratories in their analysis of these persistant organic pollutants (POPs).

We are pleased to introduce a PCN window defining solution/mixture (PCN-WD), two PCN major congeners solutions/mixtures (PCN-HWX and PCN-INC), and a PCN potentially toxic congeners solution/mixture (PCN-TOX). Please see the tables below for the composition of these mixtures.
